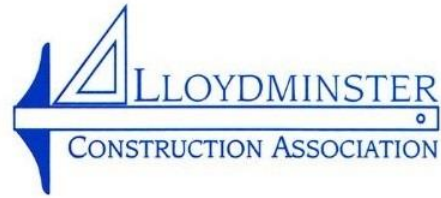

- **Construction Estimating** - Participants will learn skills and knowledge to estimate construction projects and prepare a successful bid. - **Project Accounting & Cost Control** - The Project Accounting and Cost Control course is designed for construction company owners, project managers, project coordinators, estimators, accountants, and staff to develop an understanding of accounting processes as it relates to construction projects. Participants will learn how to design and read various construction financial reports and improve the financial systems of their construction company
- **Project Management Essentials** - Participants will develop skills and knowledge of how to manage a construction project. Participants will gain an understanding of the project processes and constraints encountered by project managers (using PMBoK approach) and how to successfully manage a complex project.

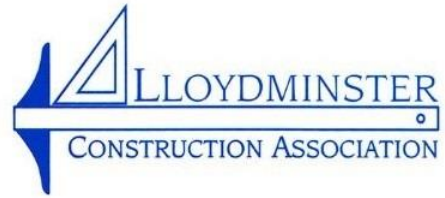
